MINUTES OF THE REGULAR MEETING OF THE HILL COUNTY WATER DISTRICT

The regular meeting of the Hill County Water District was held on April 5, 2023, at the District's office at Hingham, Montana.

RECOGNITION OF VISITORS: No visitors were present.

CALL TO ORDER:

The meeting was called to order at 7:30 p.m. by President Lowell Strissel, who acted as Chairman. All board members were present, except Shane Borlaug, and the chairman declared a quorum present. Also present was Manager Scott Decker and Secretary Tammy Pike.

<u>PUBLIC COMMENTS</u>: No other members of the public were present or made any comments.

APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:

EMPLOYEE REPORT: Scott Decker reported the Grundfos pump/motors should be shipped out April 11, 2023 and will be installed as soon as they are received.

Mr. Decker also reported the three-year samples have been taken. These samples are part of the nine-year sample cycle.

Mr. Decker advised Maguire Iron is still planning on repairing and painting the tanks in Joplin and Hingham in early fall. The Joplin tank may be painted in the spring when they paint the Chester tank if there is time.

Mr. Decker reported on obtaining a new pickup. Discussion took place on ordering another pickup due to the current pickups having high mileage. The Board advised Mr. Decker to order another vehicle from Tilleman Motors.

Mr. Decker discussed the lead and copper inventory required by DEQ. All towns and branch lines as well as homeowners will be required to provide detailed information regarding services lines in streets, homes and buildings. The deadline to provide the information to DEQ is October 24, 2024.

Mr. Decker advised the District will begin billing the towns for water loss when we bill for April 2023 services later this month.
