#### MINUTES OF THE REGULAR MEETING OF THE HILL COUNTY WATER DISTRICT

The regular meeting of the Hill County Water District was held on December 2, 2015, at the District's shop/office at Hingham, Montana.

**RECOGNITION OF VISITORS:** No visitors were present.

### **CALL TO ORDER:**

The meeting was called to order at 7:30 p.m. by President Dave Jones, who acted as Chairman. All board members were present except Lowell Strissel and Larry Fossen and the chairman declared a quorum present. Also present were Secretary Tammy Pike and Manager Scott Decker.

**PUBLIC COMMENTS**: No other members of the public were present or made any comments.

## **APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:**

The Chairman asked for corrections or additions to the minutes of the October 28, 2015 regular board meeting previously received by all board members. On motion by Larry Olson, seconded by Dan Hybner, the Board approved the minutes of the October 28, 2015 regular board meeting.

#### **NEW BUSINESS:**

<u>EMPLOYEE REPORTS</u>: Scott Decker reported the Montana Department of Environmental Quality changed the District to a three year sampling cycle for lead and copper samples. The District was previously on an annual sampling cycle for lead and copper samples.

Mr. Decker estimates that water usage will be around 94,000,000 gallons by the end of the year. The District will have pumped approximately 10,000,000 gallons more than last year.

Mr. Decker also informed the Board employees are currently performing maintenance on the system's monitoring equipment.

## **OTHER NEW BUSINESS:**

<u>JOPLIN WATER USERS ASSOCIATION</u>: Rob Moog discussed with the Board ongoing issues the Association has been facing with regards to charges to users. The Board discussed the matter and reiterated that rates are uniformly set system wide.

**NORTH CENTRAL REGIONAL WATER AUTHORITY:** Rob Moog discussed the revised Interlocal Agreement with the Board. Mr. Moog advised the Board several changes have been made to the Agreement and should be reviewed by board members. Upon further discussion the Board advised Tammy Pike to contact Jody Hellegaard for a copy of the previous Agreement. Ms. Pike will provide the Agreements to board members for review.

Dave Jones also discussed stepping down as a District representative on the Regional Water Authority board. The Board discussed the matter and Dan Hybner agreed to take his place. The Board instructed Tammy Pike to contact Jody Hellegaard regarding the next meeting and procedure on replacement of a representative.
