The regular meeting of the Hill County Water District was held on January 8, 2020 at the District's office at Hingham, Montana.

RECOGNITION OF VISITORS: Jody Hellegaard, General Manager, North Central Montana Regional Water Authority, Nate Weisenburger, PE, AE2S and Tim Peet, district water user.

CALL TO ORDER:

The meeting was called to order at 7:30 p.m. by President Dave Jones, who acted as Chairman. All board members were present except Larry Fossen and the chairman declared a quorum present. Also present was Manager Scott Decker and Secretary Tammy Pike.

ROCKY BOY NORTH CENTRAL REGIONAL WATER PROJECT: Without objection, the Chairman changed the order of business and called upon Jody Hellegaard and Nate Weisenburger to address the Board. Ms. Hellegaard and Mr. Weisenburger reported on the progress with the water treatment plant, funding short falls and which segments would be receiving water first. Further discussion took place on several aspects of the project.
