MINUTES OF THE REGULAR MEETING OF THE HILL COUNTY WATER DISTRICT

The regular meeting of the Hill County Water District was held on June 7, 2023, at the District's office at Hingham, Montana.

RECOGNITION OF VISITORS: No visitors were present.

CALL TO ORDER:

The meeting was called to order at 7:30 p.m. by President Lowell Strissel, who acted as Chairman. All board members were present, except Rob Moog and the chairman declared a quorum present. Also present was Manager Scott Decker and Secretary Tammy Pike.

<u>PUBLIC COMMENTS</u>: No other members of the public were present or made any comments.

APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:

The Chairman asked for corrections or additions to the minutes of the May 3, 2023, regular board meeting previously received by all board members. On motion by Tina Wood, seconded by Shane Borlaug, the Board approved the minutes of the May 3, 2023, regular board meeting.

NEW BUSINESS:

EMPLOYEE REPORT: Scott Decker reported Sunrise Financial did not accept the offer on the lot in Inverness near the pumpstation.

Mr. Decker advised 130 satellite meters have been installed so far and the rest should be completed within the next month.

PERSONNEL COMMITTEE: Larry Fossen reported the Committee held interviews. Dan Hybner discussed the applicants and the recommendations made by the Committee. The Board discussed the matter further and on motion by Shane Borlaug, seconded by Kevin Springer, the Board advised Scott Decker to send an offer of employment.

<u>CD RENEWAL</u>: Tammy Pike referred the Board to the Investment Report included with the meeting materials. She reported that a portion of the District's existing CD investments is subject to reinvestment in June. Ms. Pike reviewed with the Board CD

investment options and quoted rates from banks noting that Independence Bank had the best rates. On motion by Tina Wood, seconded by Jason Myers, the Board approved renewing the existing CD at Independence Bank for one year at a rate of 4.25% and authorized the officers to execute any documents required.

<u>PINION</u>: Tammy Pike advised that Pinion is phasing out their work with water districts and the District will need to hire another accountant to prepare quarterly compilation and review financial reports. Pinion will complete the final compilation and review through year end of June 30, 2023. Ms. Pike is in the process of contacting accountants for quotes to complete quarterly compilation and review financial reports.

<u>APPOINTEE TERMS</u>: Tammy Pike advised the terms for Tina Wood and Jason Myers are up this year. Ms. Wood and Mr. Myers expressed interest in serving another term. Ms. Pike will contact the appropriate groups to have Ms. Wood and Mr. Myers reappointed to another term.
