The regular meeting of the Hill County Water District was held on March 3, 2016, at the District's shop/office at Hingham, Montana.

RECOGNITION OF VISITORS: No visitors were present.

CALL TO ORDER:

The meeting was called to order at 7:30 p.m. by Vice President Lowell Strissel, who acted as Chairman. All board members were present except Dave Jones and Larry Fossen and the chairman declared a quorum present. Also present were Secretary Tammy Pike and Manager Scott Decker.

PUBLIC COMMENTS: No other members of the public were present or made any comments.

APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:

The Chairman asked for corrections or additions to the minutes of the February 10, 2016 regular board meeting previously received by all board members. On motion by Larry Olson, seconded by Dan Hybner, the Board approved the minutes of the February 10, 2016 regular board meeting.

NEW BUSINESS:

WEB SITE: Tammy Pike announced the launching of the District's website. Ms. Pike discussed and reviewed with the Board several key areas of the website. The website includes the agenda and minutes for meetings, annual water quality report, rules and regulations, information on rates, obtaining bulk keys and much more. <u>EMPLOYEE REPORTS</u>: Scott Decker reported the two wheel drive Chevrolet pickup has over 110,000 miles on it and the 2012 Ford has 90,000 on it. Bids should be obtained to replace the Chevrolet pickup with a four wheel drive pickup. The Board discussed the matter and advised Mr. Decker to obtain bids for discussion at the next regular meeting.

Mr. Decker advised the Board a new valve was installed on pump 3 and a check valve was installed on the fire pump in Joplin. Mr. Decker also advised the Board the wiring for the pump house will need to be redone. The motors will be wired into the existing breaker boxes and scada system. The Board discussed the matter and advised Mr. Decker to contact R and R Pumps to discuss how the motors were wired when they installed the pumps.

Mr. Decker reported a new four inch gate valve and spool going to the bulk water have been replaced in the Hingham pump house. Mr. Decker also completed annual maintenance and had the clay valve for the tank fill rebuilt.

Mr. Decker attended the Rural Water conference in Great Falls earlier this month and found an Octave meter that would replace the existing Siemens meters that were installed in 2013. The Octave meter has no external head and can be incorporated with the MRX 920 meter reading system which we currently use. The Board discussed the matter further and advised Mr. Decker to purchase the Octave meters to replace the existing Siemens meters.

Mr. Decker advised the Board Dale Fletcher of GC Systems has received the information on Pumpstations 1 and 2 to design a valve that will throttle the pump rates according to demand. Mr. Decker should have information from Mr. Fletcher in approximately six weeks.
