#### MINUTES OF THE REGULAR MEETING OF THE HILL COUNTY WATER DISTRICT

The regular meeting of the Hill County Water District was held on November 9, 2022, at the District's office at Hingham, Montana.

**RECOGNITION OF VISITORS:** No visitors were present.

## **CALL TO ORDER:**

The meeting was called to order at 7:30 p.m. by President Lowell Strissel, who acted as Chairman. All board members were present and the chairman declared a quorum present. Also present was Manager Scott Decker and Secretary Tammy Pike.

**PUBLIC COMMENTS**: No other members of the public were present or made any comments.

# **APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:**

The Chairman asked for corrections or additions to the minutes of the October 5, 2022, regular board meeting previously received by all board members. On motion by Tina Wood, seconded by Kevin Springer, the Board approved the minutes of the October 5, 2022, regular board meeting.

**LANAY KAPPERUD:** Board members expressed their sadness and sincere feelings of loss at the death of LaNay Kapperud. The Board members discussed the resulting vacancy on the Board, noting that Mr. Kapperud's position was a Hill County appointive position. The Board members discussed Shane Borlaug to fill the position. Tammy Pike will contact Mr. Borlaug and the Hill County Commissioners.

#### **NEW BUSINESS:**

EMPLOYEE REPORT: Scott Decker advised the water release into the Marias River though April or May 2023 will be down around 500 cfs.

Mr. Decker reported on increasing the flow at BPS#1 to 410 gmp to test the infiltration gallery and the pumps abilities.

Mr. Decker advised the Grundfoss pumps for Inverness to Joplin have been sized. The pumps are designed to each pump from about 60 gpm to 140 gpm. Mr. Decker will also install new valves to allow for higher water flow for the pumps.

Mr. Decker reported on contacting the Montana Rural Water apprenticeship program for possible candidates to hire upon his retirement.

Mr. Decker advised the CMIU's and antennas have arrived and will be installed as weather permits.

Mr. Decker also advised the pickup that Tammy Pike drives is still at Tillemans with electrical draw issues.

<u>FINANCIAL REPORT</u>: Tammy Pike referred the Board to the 1<sup>st</sup> quarter financial report completed by Anderson Zurmuehlen and the Profit & Loss Statements included with the meeting materials. Ms. Pike noted water system revenues were up 13% from the previous year, expenses were up 15% from the previous year and the net position increased 9% from the previous year. The Board reviewed the reports and discussion took place. On motion by Tina Wood, seconded by Jason Myers, the Board approved the reports as presented.

<u>PERSONNEL COMMITTEE</u>: Larry Fossen reported on the committee's meeting to review the evaluations for employees. The committee recommended rehiring all employees with raises. On motion by Larry Fossen, seconded by Dan Hybner, the Board approved rehiring the employees with raises, effective as of the November 2022 pay period.
