#### MINUTES OF THE REGULAR MEETING OF THE HILL COUNTY WATER DISTRICT

The regular meeting of the Hill County Water District was held on September 2, 2015, at the District's shop/office at Hingham, Montana.

**RECOGNITION OF VISITORS:** No visitors were present.

#### **CALL TO ORDER:**

The meeting was called to order at 8:00 p.m. by President Dave Jones, who acted as Chairman. All board members were present except Kevin Springer and the chairman declared a quorum present. Also present were Secretary Tammy Pike and Manager Scott Decker.

**PUBLIC COMMENTS**: No other members of the public were present or made any comments.

### **APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:**

The Chairman asked for corrections or additions to the minutes of the August 5, 2015 regular board meeting previously received by all board members. On motion by Lowell Strissel, seconded by Larry Olson, the Board approved the minutes of the August 5, 2015 regular board meeting.

#### **NEW BUSINESS:**

<u>EMPLOYEE REPORTS</u>: Scott Decker reported that the bulk water controllers have arrived and installation will begin in Gildford on September 10, 2015.

Mr. Decker also reported that the Seimens meters used for the branch lines are not working accurately and will eventually need to be replaced with Neptune meters. A one way check valve will also be installed at the time of the meter replacement.

Mr. Decker informed the Board the DBP samples came back and the numbers were well below the Montana Department of Environmental Quality regulations.

Mr. Decker also advised the Board that he received another notice from the Bureau of Reclamation stating that the Marias River flow has been reduced to 500 cfs.

<u>FINANCIAL REPORT</u>: Tammy Pike referred the Board to the revised contract prepared by Anderson Zurmuehlen included with the meeting materials. The Board reviewed the

revised contract which included the fee for quarterly services and discussion took place. On motion by Larry Fossen, seconded by Rob Moog, the Board approved the revised contract and authorized execution of the same.

BOARD MEMBER ELECTIONS: Tammy Pike informed the Board she received a letter from the Clerk & Recorder's Office. No additional persons have filed in connection with the upcoming election to the Board of Directors. As a result, the Clerk & Recorder canceled the election and the candidates can immediately be appointed. On motion by Larry Olson, seconded by Dan Hybner, the Board declared Larry Fossen and Rob Moog elected by acclamation to a 4 year term each. Ms. Pike will complete the election documentation and return it to the Clerk & Recorder's Office.
