MINUTES OF THE REGULAR MEETING OF THE HILL COUNTY WATER DISTRICT

The regular meeting of the Hill County Water District was held on September 4, 2024, at the District's office at Hingham, Montana.

RECOGNITION OF VISITORS: None.

CALL TO ORDER:

The meeting was called to order at 6:00 p.m. by President Lowell Strissel, who acted as Chairman. All board members were present except Dan Hybner and Shane Borlaug and the chairman declared a quorum present. Also present was Manager Chad Hedges and Secretary Tammy Pike.

APPROVAL OF MINUTES FROM PREVIOUS MEETINGS:

The Chairman asked for corrections or additions to the minutes of the August 7, 2024, regular board meeting previously received by all board members. On motion by Larry Fossen, seconded by Kevin Springer, the Board approved the minutes of the August 7, 2024, regular board meeting as presented.

OLD BUSINESS:

Chad Hedges reported the water loss for Rudyard for August 2024 services were down from the previous month.

EMPLOYEE REPORT: Chad Hedges advised the Notice to Conserve has been lifted.

Mr. Hedges reported the new chlorine heads and smart valve were installed in the pumpstations.

Mr. Hedges also reported the crane used to remove and replace pump 2 at BPS 1 will be available after seeding season is complete.

Mr. Hedges advised he will be replacing the mag meter in the Inverness pumpstation next week.

Mr. Hedges reported as soon as he has confirmation on the connection size for the community center being built in Rudyard, he will order the parts.

Mr. Hedges also reported the parts were ordered for the Lipp connection and the line for the new service will be tapped when all the parts have arrived.

<u>FINANCIAL REPORT</u>: Tammy Pike referred the Board to the 4th quarter financial report completed by Douglas Wilson & Company, P.C., the Profit & Loss Statement and the proposed Budget included with the meeting materials. Ms. Pike noted water system revenues were down 4% from the previous year, expenses were down 13% from the previous year and the net position increased 111% from the previous year. The Board reviewed the reports and discussion took place. On motion by Rob Moog, seconded by Larry Fossen, the Board approved the reports as presented.
